What is this product?

Type

This product is a share class of AXA INVESTPLUS EQUITY SATELLITE, itself a sub-fund of AXA INVESTPLUS, an investment company with variable share capital and is governed by Luxembourg law.

Objectives

Investment objective The Fund invests mainly in other funds invested in turn in worldwide stock exchanges. For performance comparison purposes only, the Sub-Fund uses a benchmark composed of 12% of the performance of the Morningstar Developed Markets Europe Target Market Exposure NR EUR Index, 47% of the Morningstar US Target Market Exposure NR EUR Index, 25% of the Morningstar Developed Markets Eurozone Target Market Exposure NR EUR Index, 10% of the Morningstar Emerging Markets Target Market Exposure NR EUR Index and 6% of the Morningstar Developed Markets Asia Pacific Target Market Exposure NR EUR Index. The Fund may evolve in a way that diverges substantially from world stock markets.

Investment policy The Fund is an actively managed fund of funds. Selection of investments follows a 'bottom up', research-based approach determined by the Investment Manager, seeking less constrained funds whose performance may diverge significantly from their benchmarks. The Fund will comprise shares and units in other funds covering mainly small-, mid- and large-cap stocks listed or traded on world stock exchanges, whether traditional or emerging.

The Investment Manager will use its extensive research (including investment due diligence and analysis, examining both qualitative and quantitative criteria) and market insight to seek out opportunities for outperformance through selection of the best funds available, as determined by the Investment Manager in its discretion.

The Investment Manager may invest up to 30% of the net assets of the Fund directly in other investments (including mainly equities and Equity Related-Securities).

The Fund may also invest up to 10% of its net assets in bank deposits, money market instruments or money market funds.

Benchmark use The Fund is actively managed. The Fund is measured against 12% of the performance of the Morningstar Developed Markets Europe Target Market Exposure NR EUR Index, 47% of the Morningstar US Target Market Exposure NR EUR Index, 25% of the Morningstar Developed Markets Eurozone Target Market Exposure NR EUR Index, 10% of the Morningstar Emerging Markets Target Market Exposure NR EUR Index and 6% of the Morningstar Developed Markets Asia Pacific Target Market Exposure NR EUR Index benchmark. The Investment Manager has the freedom to invest in securities that are not part of the benchmark. The Fund may deviate significantly from the benchmark.

Redemption and Dealing Shares of the Fund may be redeemed on demand, with dealing normally on a daily basis.

Distribution Policy For Accumulation share classes (Acc), the dividend is reinvested.

Intended retail investor

This product is suitable for investors seeking to maximise total return from income and capital growth over a medium to long-term horizon and who are willing to accept a medium to high level of volatility.

Term

The Fund has no maturity date. The fund may be liquidated at the discretion of the Board of Directors if the net assets of the fund fall below EUR 1,250,000. The decision to liquidate shall be published or communicated to shareholders before the effective date of the liquidation.



What are the risks and what could I get in return? Risks

Performance scenarios

What happens if AXA Investment Managers Paris is unable to pay out?
