What is this product?

This product is an investment fund. AXA Selection Income is a sub-fund of Architas Multi-Manager Global Funds Unit Trust, an open-ended unit trust with segregated liability between its sub-funds authorised by the Central Bank of Ireland pursuant to the provisions of the UCITS Regulations/the European Communities (Undertakings for Collective Investment in Transferable Securities) Regulations 2011 (S.I. No. 352 of 2011), as may be amended from time to time.

Objectives

Investment objective The aim of the Fund is to provide an attractive level of income relative to prevailing interest rates while aiming to maintain or grow capital over the medium to long term.

Investment policy The Fund is an actively managed fund of funds. The Fund will be managed on a discretionary basis and will invest in other funds (underlying funds) and also make direct investments.

The underlying funds will be invested in a diverse range of asset classes including fixed-income securities, shares, money market instruments, commodities, real estate, derivatives, financial indices and/or currencies.

The direct investments may include shares, tradable debt issued by companies, governments and other institutions and money-market instruments.

The Fund can invest flexibly and is not subject to any limitation on the portion of its assets that may be invested in any one country, region, sector or asset class and may have significant exposure to emerging markets.

The Fund may also invest in financial contracts that derive their values from those of other investment instruments or indices (derivatives) to achieve the investment objective, to reduce risk or manage the fund more efficiently.

Benchmark use The Fund does not have a benchmark.

Redemption and Dealing Units of the Fund may be redeemed on demand, with dealing normally on a daily basis.

Term

The Fund has no maturity date. All the units of the Fund may be redeemed at the discretion of Architas Multi-Manager Europe Limited, if, after the first anniversary of the first issue of the Units in the Fund, the Net Asset Value of the Fund falls, for a period of 30 consecutive days or more, below \in 840,000 or its foreign currency equivalent. A unitholder notification will be sent at least one month prior to the actual termination date.

Performance scenarios

What happens if Architas Multi-Manager Europe Limited is unable to pay out?
